All errors and all rights of exemption, appeal, stay of execution, inquisition and extension upon any levy on real estate or personal property to which the customer otherwise may be entitled under laws of the United States of America now in force or which hereafter may be passed. The authority and power to appear for and enter judgment against the customer shall not be exhausted by one or more exercises thereof, or by any imperfect exercise thereof, and shall not be extinguished by a judgment entered pursuant thereto. Such authority and power may be exercised on one or more occasions, from time to time, in the same or different jurisdictions, as often as the creditor shall deem necessary or desirable, for all of which this agreement shall be a sufficient warrant.
